## I. INTRODUCTION

Southern Maryland records on microfilm are housed in the black, five-drawer cabinet located at the end of the first range of books. Types of records include population census, agricultural census, wills, land records, court records, church records, marriage, and tax assessments.

Newspapers in circulation in Southern Maryland are located in room LR210. For more information about these newspapers, please refer to the Southern Maryland Studies Center's *Southern Maryland Newspapers on Microfilm* Guide.

## II. HOW TO USE THIS GUIDE

### A. Arrangement of Microfilm

The microfilm is arranged two ways, intellectually and physically. Intellectual arrangement is as follows:

The microfilm is arranged first in alphabetical order by County, then State, then Federal, and finally, Miscellaneous. The County Microfilm is obtained from the Maryland State Archives (MSA) and is arranged alphabetically by county agency, then date span, followed by the MSA microfilm number. State Microfilm obtained from MSA is arranged alphabetically by agency, then date span, followed by the MSA microfilm number. The Federal Microfilm is obtained from the National Archives and is arranged by Record Group Number. Miscellaneous microfilm is obtained from various sources and is not arranged in any particular order.

Physical arrangement is as follows:

Microfilm from the Maryland State Archives is filed first and is arranged alphabetically by MSA microfilm number. Microfilm from the National Archives follows and is arranged numerically. Miscellaneous microfilm is located in Drawer 6. See "The Calvert Papers: Calendar and Guide to the Microfilm Edition" by Donna M. Ellis and Karen A. Stuart, call number Md F184.C28 1989; for more information about the Calvert Papers and how to use the microfilm. The Maryland Agricultural and Manufacturing Census and microfilm obtained from other institutions are located in Drawer 3.

### B. Finding Microfilm

To find a specific microfilm reel, first determine the County the record originated in; second, determine which county agency created the record; third, find the date span the record was recorded; fourth, find the Volume

number and the corresponding microfilm number. Once you have the microfilm number proceed to the appropriate drawer to find the microfilm reel.

Example: To obtain a copy of a Deed for a piece of property Josias H. Hawkins sold to Benjamin Swann. Use the Charles County General Index to Deeds to find the date the property was sold, 1858, the Liber Number, SJ, the Book or Volume number, 2, and the page number. Turn to the Charles County section of this Guide and look up land records. Find the date span 1858 would be included in and match up the Liber and Book number. The microfilm number for SJ 2 is CR 5579-1. The -1 at the end of the microfilm number indicates in what part of the film the deed is located. Using the page number allows you to go directly to the record.
